The procedure applicable to this procurement is **simplified** tender procedure.

Submitted offer will be evaluated by an evaluation committee. The evaluation committee members selected for this tender procedure are:

1. Kujtim Deari, – chairperson & evaluator
2. Daniela Simova, – secretary & evaluator
3. Lejla Zekirovska, Business Facilitator& Local Dissemination and Outreach Officer– evaluator

As a result of its deliberations, the evaluation committee may make any of the following recommendations:

Option 1: To award the contract to the tenderer that has submitted a tender:

- that complies with the formal requirements and the eligibility rules;

- whose total budget is within the maximum budget available for the project;
- that meets the minimum technical requirements specified in the tender dossier;
- that is the least expensive tender.

Option 2: To cancel to tender procedure.

At the latest during the evaluation procedure and before taking the award decision, the contracting authority Roma Entrepreneurship Development Initiative REDI Skopje ensures that there is no record of the successful tenderer, including consortium members, subcontractors or capacity providing entities, if any, in exclusion situation in the EDES ([EDES database](https://www.edesdatabase.eu)) nor in the lists of EU restrictive measures (www.sanctionsmap.eu).

During the evaluation procedure and before taking the award decision, the contracting authority will request the original Declaration on honour on exclusion criteria and selection criteria and copies of documentary evidence for exclusion and selection criteria from the potential successful tenderer. If upon verification, the evaluation committee considers the submitted evidence not admissible, it will request the same evidence from the second-best ranked tenderer.
