Article 1 Subject

The subject of the contract shall be the supply of the following supplies:

4 Office Desks - Working stations for staff: 120x80x75 cm – Approx. 300 EUR

5 Office Desk Working stations for Business Center: approx. 135x60x75 cm - Approx. 300 EUR

9 Office Chairs - Working stations for staff: Approx. 75 EUR

9 Lockable Storage Drawers - Working stations: Length:44 x Depth:40 x Height:106 Drawer interior: Length 36.8 x Depth:33.5 Approx. 135 EUR

1 Conference Table for 10 people - Dimensions approx. 270 x 120 x 76 cm - Approx. 800 EUR

10 Stable Chairs – Approx. 60 EUR

2 Storage Space Units: Total dimensions: 230cm height, with a 100cm width and 45cm depth - Approx. 400 EUR

2 Conference Tables for 6 people - Dimensions approx. 180 x 120 x 76 cm Approx. 400 EUR

8 Ergonomic Chairs - Working stations for staff - Approx. 150 EUR

The place of acceptance of the supplies shall be Nis, Serbia, the time limits for delivery shall be maximum of 70 days from the publishing the tender and the Incoterm applicable shall be DDP⁴. The implementation period of tasks shall run from 45 days from the date of receiving the award notification.

- 1.2 The contractor shall comply strictly with the terms of the special conditions and the technical annex.
- 1.3 The supplies which form the supply of furniture must be accompanied by the spare parts described by the contractor in its tender and by the accessories and other items necessary for using the goods over a period of 2 (two) years, as specified in the instructions to tenderers.

Article 2 Origin

The rules of origin of the goods are defined in Article 10 of the special conditions.

When required, a certificate of origin for the goods must be provided by the contractor at the latest when it requests provisional acceptance of the goods. Failure to comply with this condition may result in the termination of the contract and/or suspension of payment.

Article 3 Price

- 3.1 The price of the supplies shall be that shown on the financial offer (specimen in Annex IV). The total maximum contract price shall be a maximum of **EUR 8.790,00 (RSD 1.030.012,20)**.
- 3.2 Payments shall be made in accordance with the general and/or special conditions (Articles 26 to 28).

Article 4 Order of precedence of contract documents

The contract is made up of the following documents, in order of precedence:

- the contract agreement;
- the special conditions
- the general conditions (Annex I);
- the technical specifications (Annex II, including clarifications before the deadline for submission of tenders);
- the technical offer (Annex III, including clarifications from the tenderer provided during tender evaluation);
- the budget breakdown (Annex IV);
