Article 1 Subject

The subject of the contract shall be the supply, delivery, and installation (if applicable) of office furniture as specified in the Technical Specifications, including the following furniture items:

- Office furniture, working station for staff - 2 desks
- Office furniture, working station for staff hair - 2 chairs
- Office furniture, working station for staff - 2 Shelves
- Office furniture (set) for Project staff - 1 Storage facility
- Office furniture (set) for Project staff - 1 Conference table
- Office furniture, working station for business center - 5 desks
- Office furniture, working station for business center - 5 chairs
- Office furniture, working station for business center - 5 shelves
- Office furniture (set) for business center - 1 Storage facility
- Office furniture (set) for business center - 8 chairs

The place of acceptance of the supplies shall be str. "Crvena Voda" br.37/1, Skopje, the time limits for delivery shall be maximum 90 days from the publishing the tender and the Incoterm applicable shall be DDP⁴. The implementation period of tasks shall run from 60 days from the date of receiving the award notification.

- 1.2 The contractor shall comply strictly with the terms of the special conditions and the technical annex.
- 1.3 The supplies which form the supply of furniture must be accompanied by the spare parts described by the contractor in its tender and by the accessories and other items necessary for using the goods over a period of 2 year, as specified in the instructions to tenderers

Article 2 Origin

The rules of origin of the goods are defined in Article 10 of the special conditions.

When required, a certificate of origin for the goods must be provided by the contractor at the latest when it requests provisional acceptance of the goods. Failure to comply with this condition may result in the termination of the contract and/or suspension of payment.

Article 3 Price

- 3.1 The price of the supplies shall be that shown on the financial offer (specimen in Annex IV). The total maximum contract price shall be a maximum 391.405 MKD (6.370 EUR).
- 3.2 Payments shall be made in accordance with the general and/or special conditions (Articles 26 to 28).

Article 4 Order of precedence of contract documents

The contract is made up of the following documents, in order of precedence:

- the contract agreement;
- the special conditions
- the general conditions (Annex I);
- the technical specifications (Annex II, including clarifications before the deadline for submission of tenders);
- the technical offer (Annex III, including clarifications from the tenderer provided during tender evaluation);
- the budget breakdown (Annex IV);

The various documents making up the contract shall be deemed to be mutually explanatory; in cases of ambiguity or divergence, they shall prevail in the order in which they appear above.

Article 5 Other specific conditions applying to the contract

For the purpose of Article 44 of the general conditions, for the part of the data transferred by the contracting authority to the European Commission:

(a) the controller for the processing of personal data carried out within the Commission is the head of contracts and finance unit R4 of DG Neighbourhood and Enlargement Negotiations.
